- Athletics eligibility will be in accordance with Alabama High School Athletic Association (AHSAA) By-Laws.
- False or misleading information discovered in this initial application for admission will be grounds for the student's withdrawal from all Marion County Schools.
- Once admitted, nonresident students with persistent discipline or attendance problems may not be readmitted in subsequent years.
- Nonresident students who incur expulsion from the District's schools shall not be readmitted.
- Students who have been suspended from former schools, have poor attendance or disciplinary records, or criminal charges against them may not be accepted.
- Placement in a requested school will be on a space and resource available basis only. The superintendent or his/her designee will make the final decision regarding the school placement.
- Nonresidents must provide transportation for their child.
- If a student does not have proof of immunization, the student may be enrolled and the parent/guardian will be instructed on how to obtain the needed immunizations.
- The student must be eligible to attend the school from which he or she is transferring.
